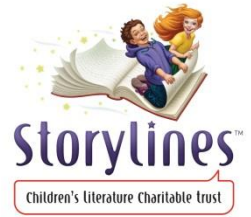

- Stories must be suitable for ages between 7 and 13 years, with a word count between 10,000 and 60,000 words. Please note the word count on the title page.
- A synopsis of no more than one page in length should be included.
- Please enclose pre-paid, self-addressed packaging of suitable size if you wish the manuscripts to be returned.
- All submissions will be treated in confidence and remain the intellectual property of the author.

Fees: \$17.50 per title for Storylines members. \$35.00 per title for non-members.
